## From noodles to sushi, Japanese cuisine makes inroads in India

Japanese food favourites such as *udon* noodles and *sushi* are gaining their presence in India. With the growing economy and population, Japanese restaurateurs are planning to woo Indian diners with Japanese-style curry.

Makoto Morikawa, runs three *udon* shops in and around New Delhi, and plans to have 30 branches within the next few years. "In the beginning, most of my customers were Japanese, but now around 50% are Indians," says Morikawa, who opened the first 'Makoto Udon' outlet in Gurugram in Dec. 2017. 'Sushi Junction', aimed at higher income brackets makes home deliveries of Sushi and other special Japanese dishes in New Delhi since 2015. Also Yoshinoya chain famed for its *gy don* beef bowl dishes opened its first shop in India in Gurugram last year. The famous Japanese curry shop 'Ichibanya Co.' plans to open its first branch in India early next year, a joint venture with Mitsui & Co.

# **IKIGAI**



**Okinawa,** the southernmost prefecture of Japan had a devastating history, losing over 2000 lives during the end of World War II. But Okinawans do not cultivate the feeling of animosity towards outsiders, they live by principle *ichariba chode* meaning "though we meet once, even by chance, we are friends for life".

Among the many places that adorn Okinawa, one special place catches the attention is a small village on the northern end of the island called Ogimi, nicknamed as "the village of longevity". It boasts of the highest life expectancy in the world. This village having a population of over 3000 has incredibly friendly residents who live amidst lush green hills embedded with crystalline waters. There are around nine centenarians with the eldest being 107 years old, and the people are very humble. A close knitted community of happy citizens grace the village and welcome any visitors with an open heart. The secret seems to be in the mysterious *Ikigai*.

*Ikigai* roughly translates to "A reason for being". In other words, the happiness of always being busy. According to the Japanese, everyone has their *Ikigai*. Some have found them, whereas others are still looking. Over the past decade, researchers have clearly noticed that the lifestyle of individuals play a vital role in the longevity and contemptuous life.

#### Rain bow diet:

As a rural village, Ogimi's people depend on local produce and seasonal crops for their everyday consumption. A typical November lunch would contain fennel, tofu, fish and sweet potato. There are at least 5 servings of fruits and vegetables every day or "eating the rainbow" as they call it. More than 30 percent of their calories come from vegetables. They rarely consume sugar and if they do, they consume cane sugar. They also have a salt intake of 7 grams per day whereas the average Japanese consumes 12 grams. The concept of *hara hachibu* seems to be prominent among existing centenarians. This concept insists on eating only till we are 80 percent full. An easy way to follow that is to skip dessert or to reduce the quantity of consumption.

#### Stress:

A major killer of longevity is stress. Most of the world is filled with it. Stress is said to be the biggest contributor for premature ageing, high blood glucose levels and elevated blood pressure. In Ogimi people are on constant move, keep themselves active and occupied and this keeps them physically fit there by adding years to their life. Finding one's Ikigai plays a major role in keeping the mind young and not caving in when faced with difficulties.

#### **Resilience:**

"Nana Korobi ya oki" (fall seven times, rise eight) is a Japanese proverb that reinforces cultivation of antifragility. Zen Buddhism promotes building emotional resilience by the art of meditation. In meditation, one becomes aware of his/her desires and emotions and thereby freeing themselves from them.

#### **Community:**

Celebrations are an essential part in Ogimi. All of them belong to some form of neighborhood association where they feel cared for like a family. The residents conduct competitions and there is no age limit for participation. Birthdays and other special occasions of residents are celebrated in the local community centre. People of Ogimi believe that this human connection keeps their outlook towards life positive and healthy.

A framed statement of the public declaration of Ogimi is hung on the wall of a roadside cafe and it reads:

"80 Years old, I am still a child. When I come to see you at 90, send me away to wait till I'm 100; Let us keep going strong as we get older, and not depend too much on our children in old age; Come to our village in your old age, and we will provide the blessings of nature and teach you the secrets of longevity; We, the senior citizens of Ogimi proudly declare this the longest lived village in Japan".

# **Changes in the Income Tax Act Rates through Ordinance**

In order to give a great thrust to the economy, the Government of India, on 20 th September 2019, promulgated an ordinance – called The Taxation Laws (Amendment) Ordinance -2019. This ordinance which is applicable for the current financial year FY2019-20 (AY 2020-21) has given certain NEW WAYS to reduce the effective corporate tax for companies paying more than 25.17 % by allowing them to exercise option at the time of filing the Return for the year ended 31-3-2020

#### Some Salient Features of this Ordinance are :

#### For companies paying effective tax more than 25.17 % :

#### (1) OPTION UNDER SEC 115BAA

If these companies, ready to forego certain allowances like additional depreciation or contribution to Scientific research Institutions (deduction under section 35 (1) (ii) etc) or certain deductions falling under part C of Chapter VIA (excepting deduction under section 80 JJ AA) or deductions under Sec 32AD, 10AA, sec 35 CCC, or sec 35CCD or any losses attributable to these sections, they can opt for lower tax at 22 % (plus fixed surcharge of 10 % plus 4 % cess) aggregating to 25.17 % from the present rate;

#### Some important conditions are :

- Option once exercised cannot be with drawn ;
- MAT will not be applicable
- MAT credit will not be available for future set off; (Government has stated that the companies can exhaust MAT credit first and then can switch over)
- MAT rate reduced from 18.5 % to 15 % for all assessees The advantages are :
- Companies can pay lower advance tax for the current Financial year even though the option has to be exercised on the due date of filing the Return in sep / November 2020.
- There are ways to reduce even the new rate below 25.17%
- Even GAAR will not be applicable here (2) NEW MANUFACTURING UNITS : OPTION UNDER SEC 115BAB Tax rate for manufacturing companies @ 15 % plus surcharge plus cess @17.16 % Newly started companies set up and registered after 1-10-2019 engaged solely in the manufacturing or production of article and research in relation to or distribution of such manufactured articles is eligible to opt for tax rate @ 15 %, subject fulfilment of certain conditions ;Even MAT will not be applicable to these companies. Even these companies cannot claim those allowances like additional depreciation etc as mentioned in the sec115BAA. Both these new sections have galvanised the approach of big corporates on their future expansion plans , and also started the process of achieving zero debt company status . Even Companies having SEZ and enjoying tax holiday benefits are contemplating big corporate restructuring exercise like amalgamation / demerger etc so that in the next few years they will move into lower effective tax rate . For achieving all this , one should have a clear vision about the future expansion plans of the business before exercising the option under these sections.

### Kudos to ANA, Chennai gets direct flight to Tokyo

The long awaited wish of the Indian and the Japanese business community has now been fulfilled. Japan's All Nippon Airways (ANA) has launched a new route connecting Chennai and Tokyo from October 27. ANA is the only airline providing direct flights from Japan to South India, and this will be ANA's third route offering service to India, along with flights from Narita to Mumbai and Delhi. The Boeing 787-8 aircraft, with 169 seats, is said to offer 46 business class seats, 21 premium economy class seats and 102 economy class seats, operating thrice a week in the route. With the increase in business interest in the Southern India, the flight service assumes significant importance.
